For this support HOTRFM will seek to provide the following ministry services at the following Levels:

SUPPORT LEVELS

ASSOCIATE LEVEL - \$150/MONTH

MEMBER DISCOUNTS:

Will be available to all HOTRFM sponsored training events ... our annual Family Ministries Conference, and any of our local **leadership** seminars.

(Fan the Flame Date Nites are not included)

Significant discounts on all non-HOTRFM resources purchased through HOTRFM. This includes books, Sunday school curriculum, bulletins, music, CD's and other church supplies as available.

A minimum 25% off on all HOTRFM produced resources.

CONGREGATIONAL ASSESSMENT OR CREDIT TOWARD FUTURE EVENTS:

The congregational assessment is a valuable tool for church leaders to gain a deeper understanding of their church family's make up and needs. We will help refine our standard online survey to meet the needs of your church. We will compile the data into a readable report with ministry recommendations. We will present this report to appropriate church leadership with our recommendations. We will help the host church develop a ministry strategy.

HOTRFM strongly recommends the assessment as a "first step" with our ministry. However, in the event that Associate churches wish to move directly to hosting a HOTRFM event, the Associate churches will be able to do so once their support reaches a requisite level. For example, a church giving \$150 of support a month would be eligible for a congregational assessment after 10 months, a HOTRFM event after an (additional) 10 months, and so on.

PARTNER LEVEL - \$250/MONTH

The benefits of the Associate Level PLUS

HOTRFM EVENT(s):

Based on the need(s) uncovered in the assessment, church leaders may elect to host an event led by HOTRFM. This event must be scheduled in conjunction with HOTRFM. The honorarium and material costs for the event are included in this agreement. The partnering church is responsible for executing all of the details surrounding the event (booking the venue, publicity, etc). Travel, meals and housing costs of HOTRFM resource person(s) will also be covered by the member church. *(This event will not take place until a minimum of \$1000 has been donated to HOTRFM per event. It should be planned at least 3 months ahead)*

CHAMPION LEVEL - \$350+ /MONTH

All of the benefits of the Associate and Partner levels PLUS

LEADERSHIP COACHING / MENTORING:

HOTRFM will conduct at least one onsite coaching session involving a full day on campus. Sessions may include facilitation of strategy, staff training, and personal coaching of leadership personnel or any combination within a 12 hour business day. *(The coach's travel, housing, and meal expenses are not covered in the agreement. Member churches will assume all costs for the training day, meals for participants, etc.)*

HOTRFM coaches/mentors will be available 2 hours per month on the phone and email. These sessions will usually center on accountability of follow through and refining of ministry strategies.

*** SMALL PRINT:**

HOTRFM will make a reasonable effort to initiate each of these member benefits. Please realize that if this partnership is going to be effective the partnering church has to be actively involved in the process.

This document is not a legally binding agreement. It is a gesture of good will made in good faith between us. Our desire is to help your church become more proactive and effective in ministering to your men, marriages, and families. These ministry services are a means of showing our appreciation for your regular support. HOTRFM will not take any legal action against member churches for failure to make monthly contributions.

Both parties will evaluate the success of this agreement at least three months prior to its termination date.
